Budget Meeting Minutes:

2017 Annual Budget:

- Brief description of last year's budget and the proposed new budget.
- Dues to be raised \$5.00 per quarter (Annually \$20.00) to be earmarked for infrastructure needs.
- Kathy gave breakdown of last year's budget rollover and expenditures done in current year. Major drainage/easement project cost \$43,000. All other items realized a net savings to budget. Expect a \$20,000 carry over in unrestricted funds from last and prior years budgets.
- Dues increase first time in 7 years.
- Next year budget very similar to this year budget.
- Budget approval moved by member Russ Bowman and seconded by Barb Hajko.

- Certified 62 units in attendance in person or by proxies by Dawn B. and quorum is satisfied.
- Notices were legally sent out.
- Called for nominations for new board members. John Racine was nominated as well as Joe Incorvia, Tom Tracy, Kathy Wilson and Lisa Hinton. Slate was motioned by Bruce Hadburg and seconded by Russ Bowman. Passed unanimously.

- All reelected board members have already read and agree to abide by Association documents. New member John Racine was provided copies and signed to agree to follow documents.
- Joe lead discussion of last year's projects and expected new projects. Ponds and beautification of grounds/islands. Pond #1 has new fountain. Three islands will be landscaped next March. Association obtained from City of Safety Harbor a grant for 50% of project cost (1373.50)
- Joinder discussed. To clean up legal paperwork and structure of association operations to conform with present needs. 75% of homeowners in each phase of the subdivision must agree and sign paperwork before Association documents can be revised. Board members are working at getting required signatures.
- Discussed sidewalk repairs for next year.
- Member brought up objection to board expenditure to change easement project after it was initially completed. So noted for record.
- Russ Bowman volunteered to be an at large member liaison to work on pond projects with board. He is a water specialist/engineer with extensive county experience in water management.
- General discussion about the pros and cons of establishing paint palette for future homeowners to repaint homes. Would require amendment to Association documents and 75% vote of approval by association members. Agreed to discuss at future board meetings.
- Appointed volunteer Helen Renshaw to architectural committee to fill vacancy.
- Waived reading of last board minutes.
- Meeting motioned for adjournment by Russ Bowman. Seconded by Bruce Hadburg.
