Pressure cleaning brick and landscaping irrigation is dependent on power and water restoration to this area. Pierre to report on progress of shallow well installation estimate. Beth to pick wall colors. Pierre to send Board all bids. Information gathering to continue, other HOAs to be consulted and no decisions made (e.g. vendors) without Board approval. Suggested a subcommittee of Doug, Kim, and Lisa be created to make recommendations on landscaping.

- John Evans resodding Marshall St. entrance (1st island only) also need to resod utility strip on Cheshire Ct. adjacent to swamp area. Doug to call John to open work order. Contract is old with vague verbiage so specific landscaping items should be submitted to the Board. (Kim to call city to request trimming of bushes along Green Springs sidewalk, otherwise John to complete work.) Landscaping committee to make further recommendations, e.g. mulch 1st island on Wyndham Way, drought tolerant plants, and wall shrubs with input from John. Doug and Kathy to get proposals.
