Breaking News:

Safety Harbor Mayor Andy Steingold visited the home of Michael and Nicole Dommer to meet with about 20 concerned residents of Huntington Trails. On 10/23/13 Harborside Christian Church filed a major amendment to their original site plan requesting a second vehicular access point at the corner of Greensprings and Marshall (the drive would be on church owned property). Mayor Steingold presented four options to the proposal:

- Option 1 after hearing, city approves the churches plan (Note The church would need to get SWFWMD approval as well). Church builds driveway and has all control over it.
- Option 2 after hearing, city does not approve the church plan due to X,Y,Z criteria. Church would sue and take X,Y,Z criteria to court. Church wins and builds driveway, Church loses and moves to option 3.
- Option 3 after hearing, city does not approve. The Church sells the property to developer (it is zoned for up to 8 houses) with right of easement for an access drive to the Church when creating access to the new houses. Church builds the driveway anyway with control over it.
- Option 4 There is a land swap proposal the City of Safety Harbor is working on. In the swap, the Church would get 3.5 acres of the 10 acre messenger property plus money, the City would in exchange receive 6.5 acres of Church property. Both City and Church property involved would be zoned preservation/green space. The church would pay for and build a 24 ft road (small enough to be only an access road) and gate. After built, the City would control the access road and the gate. The City wants to get dirt fill from part of the Messenger property for the new waterfront park, access for that would be included. City staff would open the gates at certain times for Church (Sunday morning, Sunday evening, Wednesday evening and X number of special events like weddings or funerals). None of these are during business traffic hours. There would be a limit on the number of vehicles. As of 4/7/14 City Commission meeting, negotiations were still underway and above may be changed. (see map on next page)

Above this line is currently Church private property. Below is City property (known as Messenger property). Proposed Land Swap would give Church area outlined in Red and the City would receive all land above line currently owned by Church.

ENHANCE YOUR HOME'S CURB APPEAL



Please remember that all structural changes, including new painting, fences and mailbox replacements, must be approved by the architectural committee before implemented. An architectural request form is included in this newsletter or may be obtained at www.huntingtontrails.org.



SIDEWALKS

Clean driveways and sidewalks blackened by mold. Please remember, that the sidewalk in front of your house is your responsibility to maintain. An internet search will find many affordable do-ityourself methods if you'd rather not hire a pro.

ROOF

Cleaning your roof will greatly enhance the beauty of your home if it has been blackened by mold.

PAINT

Is your house color starting to fade? Does the color vary due to sun exposure? If so, it's probably time to consider painting your house

FENCE

Is your fence falling down? Does it need cleaning? Replacing? Repair and/or repaint fences that may be deteriorating. Do NOT paint interior of perimeter wall if your property abuts to it.

LAWN, MAILBOX & HOUSE NUMBER

Maintain lawns in good condition. Trim back and dispose of dead plants, tree limbs/palm fronds and replace if needed. The city picks up yard waste every Wednesday and requests that it be placed in manageable bundles or 32 gallon or smaller trash cans.

Repair/Replace mailboxes which are leaning, damaged or weathered.

Ensure your house has a legibly displayed house number. Not only is this helpful for your friends to find your home but it will also assist emergency personnel if needed.
